

Original Owners Limited Lifetime product warranty

SUV's vinyl fencing products are manufactured using quality raw materials and are produced with engineering excellence designed for years of maintenance-free performance, SUV warrants that these products will be free from defects in materials and manufacturing workmanship for the lifetime of the original owner of the property. SUV warrants to the original homeowner/consumer that its SUV vinyl fence products will be free from manufacturing defects-including peeling, flaking, blistering and corroding-when subject to normal and proper use.

Should any such defect occur during the lifetime of the original purchaser (and as long as the original purchaser is still living and retains ownership of the property), SUV will repair or replace, at its option, the defective fence product. SUV also reserves the right to refund the amount paid by the original owner for the fence. SUV shall not be liable or responsible for labor charges or other expenses whatsoever in connection with removal or installation of either the original or replacement product. In the event of repair or replacement under the terms of this warranty, the original warranty shall apply to the repaired or replacement fence material, and will extend for the balance of the warranty period in effect at the time the material proved defective. The lifetime coverage offered by this warranty is designed to cover individual homeowners only. In the case of fence material purchased by, or installed upon property owned by, corporations, governmental agencies, partnerships, trusts, religious organizations schools, condominiums or cooperative housing arrangements, or installed on apartment buildings or any other type of building or premises not used by individual homeowners as their residences, the warranty period will be 30 years following the installation of the fence.

Limitations

This warranty does not provide protection against any failure, defect or damage caused by Situations and events beyond normal exposure conditions, including but not limited to:

- Misuse, abuse, neglect or improper handling or storage;
- Improper installation ;
- Use of accessories which do not properly receive and/or secure SUV fence;
- Impact of foreign objects, fire, earthquake, flood, lightning, hail, hurricane, tornado or other casualties or acts of God;
- Movement, distortion, collapse or settling of the ground or structure on which the fence is installed;
- Any other cause not involving manufacturing defects in the material supplied by SUV.

The fence is not warranted against discoloration or other damage caused by air pollution (including but not limited to metal oxides or metallic particles), mildew, exposure to harmful chemicals or normal weathering from the elements. Normal weathering is defined as exposure to sunlight and extremes of weather and atmosphere which will cause any colored surface to gradually fade, chalk, or accumulate dirt or stains. The severity of any condition depends on the geographical location of the fence, the cleanliness of the air in the area, and many other influences over which SUV has no control. Notwithstanding anything set forth above, the fence is warranted against yellowing of the product due to normal weathering from the elements. SUV shall have sole discretion to determine, based on reasonable criteria, whether the fence is suffering from normal weathering. If the fence weathers to a degree determined by SUV to be beyond normal, SUV will either repair or provide replacement material, at its option, for the defective fence. SUV also reserves the right to refund the amount paid by the original owner for the fence material and accessories (but not including the cost of its initial installation).

This warranty does not apply to fence which has been painted, varnished or coated over the manufacturer's original finish. SUV reserves the right to discontinue or modify any of its products, including the color, without notice to the homeowner/consumer, nor shall SUV be liable in the event the replacement material may vary in color or gloss in comparison to the original product as a result of normal weathering. If SUV replaces any material under this warranty, it may substitute products designated by SUV to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

Transferability

This Limited Warranty is personal to the original purchaser of Products, and cannot be assigned or transferred except under the following conditions and one time only: (a) The original homeowner may transfer the lifetime warranty rights conferred by this Limited Warranty in connection with the sale of his or her residence to another individual who uses the property for personal residence; provided, however that notification of the property transferred must be received by Manufacturer within (30) days of the transfer of the subject property; and (b) All other original purchasers may transfer the rights conferred upon them by this Limited Warranty only to an individual homeowner.

Other Conditions

THIS WARRANTY REPLACES ALL OTHER ORAL OR WRITTEN WARRANTIES, LIABILITIES OR OBLIGATIONS OF SUV. PERTINENT STATE LAW SHALL CONTROL FOR WHAT PERIOD OF TIME FOLLOWING THE SALE A HOMEOWNER/CONSUMER MAY SEEK A REMEDY UNDER THE IMPLIED WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL SUV BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING ANY DAMAGE TO THE BUILDING, ITS CONTENTS OR ANY PERSON THEREIN, RESULTING FROM THE BREACH OF THIS WARRANTY. SUV DOES NOT AUTHORIZE ITS FIELD REPRESENTATIVES, DISTRIBUTORS OR DEALERS TO MAKE ANY CHANGE OR MODIFICATION TO THIS WARRANTY. SOME STATES DO NOT ALLOW LIMITATIONS ON, OR THE EXCLUSION OF, INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSIONS MAY NOT APPLY TO YOU.

This warranty gives you specific legal rights, and you may also have other rights which may vary from state to state.

What the Customer Must Do

The homeowner/consumer must promptly notify SUV in writing of any manufacturing defect and provide proof of the date of purchase and installation, as well as proof of property ownership. All notifications should be sent to: SUV Corporation, P.O. Box 1735 San Bernardino, CA 92402, Attn: Consumer Services Department. The consumer may be required to submit a sample of the defective material to SUV for analysis. SUV will then investigate the claim and may examine the material claimed to be defective. If a defect covered by this warranty is confirmed, SUV, within a reasonable amount of time after the inspection, will repair or provide replacement material for the fence, or refund the amount paid by the original owner for the fence and accessories, per the terms of this warranty.

LIMITED LIFETIME WARRANTY

SUV stands behind its products with a Limited Lifetime Transferable Product Warranty. A SUV fence is warranted against manufacturing defects for your lifetime, allowing you to rest easy that your decision to choose a SUV product was the right one.

If your product contains manufacturing defects covered by this Warranty, Superior Universal Vinyl, Inc. will, at its option, repair or replace the defective product at a cost not to exceed the original purchase price of the product. The Warranty period shall not be extended by any such repair, replacement, or refund settlements. Superior Universal Vinyl, Inc. will not be liable for labor charges or other costs or expenses in connection with the repair, removal or installation of the original or replacement product. Superior Universal Vinyl, Inc. may direct and pay a company, dealer, contractor applicator or distributor to perform any remedy under this Warrant on Superior Universal Vinyl, Inc.'s behalf.
